

### Council Report – Leighanne Gardipy-Bill Spring 2015

Tansi,

First, I would like to thank the Governance Committee for their time, work and dedication to the Constitutional development project. We completed one consultation session with youth and Elders, one community consultation session at the rec centre and one off reserve consultation session in Prince Albert. Next we will be meeting with band members in Saskatoon and Regina. The draft constitution is also posted online along with a video recording of the session at the rec centre and a link to our online survey. For this fiscal year the Governance Committee received funding to revise our *Election Act*. We will be planning a round of consultation sessions on this project in the near future. Our goal is to have a vote on both the *Constitution* and amended *Election Act* next Treaty day.

In regards to the Health Centre, Willow Cree Health Services Inc is currently working towards becoming accredited through the Canadian Accreditation Council. The accreditation process will help guide the Health Centre towards an enhanced standard of service delivery.

I have also been asked to oversee the BHP Billiton agreement. As you may be aware, BHP Billiton is in the process of building a potash mine by our lands near Wynyard, Saskatchewan. Negotiations with BHP initiated July 2011 and on October 7, 2014 the Beardy's & Okemasis First Nation finalized an opportunities agreement with BHP Billiton Canada Inc. The next phase of our dealings with BHP is to ensure the opportunities agreement is implemented effectively and opportunities flow to our Nation. This agreement has the potential to benefit our community in the areas of education and training, community development, employment, capacity building and business opportunities.



QBOCFS hours of operations are as follows: 8:30am – 4:30pm Monday – Friday (closed for lunch).


An open house will be set at a later date due to technical problems with the phone system. Staff are currently using cell phones. The phone problem should be solved by next week.

Hello everyone! I am updating you on the areas that I take care of in our community. First, I am very proud to be serving our community and our people. I wake up and look forward to my day, and thankful for the people I work with, we have good hardworking employees.

A) Willow Cree Education and Training Center- the center in Duck Lake has wonderful programs happening; The Community-Based ITEP program, which has students from Beardy''s and surrounding reserves attending. These students have just finished their second year, so in 2017 they will all become teachers (with a Bachelor of Education Degree). Very proud of these students. ABE Program, The Adult Basic Education program has been running for some time already, this program helps students who need their Grade 10, there is an instructor (Bill Brace) who teaches at the Education Center. 

# C. Roy Petit Councillor i/c of Public Works & Housing Beardy - Okemasis Willow Cree Nation #96 & #97

The Public Works & Housing programs (PW&H) are two of the most important programs in our community; they are also two of the least understood.

I am putting this information together in order to try and assist our members in familiarizing themselves with these programs; I hope that this will provide a clearer understanding about which each of these programs provides to our community and how we can all help to make it more productive.

"Please take time to read this; it is of vital importance to our future."

### PW&H at a Glance:

Population on reserve: Estimated at about 1,500 with many transient members; Population off reserve: Estimated at about 1,800 with many transient members; Homes on reserve: 326 Homes - Band and Private - from 5-40 years old; Buildings: Band Office, Arena, Elementary and High Schools, Day Care, Rec. Center, Senior's Hall, RCMP Station, Justice Building, Fire Hall, Water Treatment Plant, Old Band Office, Heavy Equipment Storage, 5 Pump Houses; Equipment: 3 Trucks, Grader, Loader, Back-hoe, Skid steer, 7 Busses...; Roads: approximately 150Km of roadways including driveways & entryways;

**Employees**: Director - Public Works & Housing, PW&H Clerk, General Maintenance Worker +Casual(s), Water Treatment Plant Operator +Casual, Heavy Equipment Operator +Casual(s), (2)On-call Electrician(s), (2)Casual Building Custodians, (3) Sanitation Services Contracts, (2) Water Contractors, (4) Custodians/Schools, (1) Maintenance/Schools.

# Yearly Funding – Aboriginal Affairs and Northern Development Canada (AANDC)

### **Operations & Maintenance**

\$1,016,770/yr deposited to our account monthly at \$85,000/mo. This amount is designated to the entire operation of the bands infrastructure, and includes salaries, contracts, equipment maintenance supplies, all insurance, fuel costs, all building maintenance including utilities, power & energy, phone, oil/propane, all maintenance to water, sewer and/or electrical, road maintenance, any other emergencies that may arise in the community pertaining to operations.

**NOTE:** \$511, 834.00 of the total O&M dollars received goes directly into our school budgets for use in their operations; this leaves the overall band O&M budget at only \$504,936.00/yr. or \$42,078/mo.

### How this funding is calculated:

AANDC will compare an R.M. or community equal to the size of our First Nation (same number of buildings, homes, population, machinery, infrastructure, employees, etc.), based on these numbers they calculate how much that R.M./community should receive in provincial funding and taxes/fees collected, to operate – whatever that amount is, we as a Band receive 20% of that total to put towards our overall operations and maintenance.

It has always been an expectation that the 80% shortfall in funding would come from the Membership/Band in the form of a 'user fee' as well as a 'insurance & maintenance fee' a total of \$118.00 is to be applied and collected from every household. In order for the band to be able to carry out the scope of work that needs to be done within our community this fee has to be fully implemented and carried on into each successive Administration.

A user fee from each household at \$118.00/mo. = \$461.616/yr. this would allow us to hire more full time Heavy Equipment Operator, another Maintenance person, more road, home and building repairs... more importantly it would keep us from seeing a deficit in Public Works every year.

It is important that the membership understand that there is no budget allocation within the O&M dollars that is, or can be designated to renovations of any band homes, these dollars are strictly designated to our community's infrastructure costs.

### **Band Based Capital**

\$691,915/yr is designated to this program and is distributed monthly based on submissions for work completed. BBC dollars are allotted to items such as major/minor/emergency renovations (*non-section95 only*), band building renovations/upgrades, driveways, insurance, equipment usage, and project management and administration fee.

Note: Not all of these dollars come to the Band; suppliers get paid directly through submissions made for material.

The BBC portion of the AANDC funding is currently under third party and is being managed by SAL Engineering, a project management firm. We must work with SAL and our AANDC designate to decide how we will expend these dollars.

Before dollars are released under this portion of funding a plan must be submitted prior to year end showing the types of projects you are planning to undertake for the coming year. During this first year we designated a large portion of these dollars to minor and emergency renovations, other amounts were designated to band building renovations, sewer and water restoration, minor fire hall renovations, insurance, a portion goes to Project Management, and a portion to Administration which is generally used to cover the Director Public Works & Housing position. Once projects have been completed, we submit invoices, etc. to the project managers and they release the money to the band or supplier of material. We are coming to the end of the fiscal year and are on task to utilize all of these dollars. There is definitely no shortage of work to be done and we will continue for as long as those dollars allow.

It is important to note that any AANDC dollars not used are generally taken back by AANDC and are <u>not</u> added to the following year's budget. Also, failure to follow through with regular reporting halts funding, so we must be diligent in following through on these processes to ensure that there are no halts to services that the PW&H programs offer to the community.

If you are in need of renovations please forward a letter to our office listing your request(s), your house number, and any contact information – your name will be added to the list that we currently have going. *Please understand that there are 326 Band Homes and we are trying to address as much as we can, when we can – be patient, be kind, thank you.* 

### **Other Funding AANDC**

Separate from our regular funding agreement dollars, Aboriginal Affairs and Northern Development Canada (AANDC) also assists with identified larger infrastructure items in the community, these are called **Major Projects**. Currently there are three (3) Major Projects that are underway in the community – the first is the flood/road rehabilitation and repair project, the second is the drainage ditch project (*planning stage*), and the third is the school rehabilitation and repair project. These projects will be ongoing throughout the year with the remaining dollars designated to each. For the coming year a new project has been submitted: the Water Treatment Plant rehabilitation and repair project.

### Housing

Canada Mortgage and Housing Corporation (CMHC) is a federal loan organization; our rating with CMHC along with our ability to secure a Ministerial Loan Guarantee from AANDC is what allows First Nation Communities to build Housing on Reserve. CMHC does not provide regular funding to the Band. Under the CMHC loan agreements we currently have 9 active phases called 'Section95 Housing'; under the 9 phases we have 64 Housing Units that are all being occupied. (House's numbered 271-350 + 188, 6 & 70).

Prior to the designation of a Section95 Band Home to an individual or family, a tenancy agreement is signed by the Band Member and the Band, this agreement outlines the responsibilities of both parties, and identifies the rental rate which is meant to cover the cost of the mortgage taken out for that particular phase.

Rent payments received from the Section95 Housing Units covers the mortgage that the band has taken in order to have these units built. As we make these mortgage payments, CMHC provides us with a subsidy which is often times almost equal to what we pay out – this subsidy goes into required separate bank accounts called 'Replacement and Operating Reserve Accounts'. The collection of rent allows our housing program immediate access to the dollars needed to address any renovation issue(s) that may arise for these 64 units and a structured program makes us eligible for more housing in the future.

<sup>\*</sup>Separate from the 64 Section95 Housing Units, there are 30 Section10 Houses that were meant to be under similar agreements, these mortgages have been paid for by the Band almost since they were built. There is no subsidy for these units.

For many First Nation Communities it has been a practice to have the Section95 house assigned to an SA client, which ensured that the rent would be covered under that program – AANDC has made it very clear that they will not allow this to continue, and will not be paying any of these rents if EVERYONE is not paying their fair share.

Example:

One (1) Tenant receiving Social Assistance

One (1) Tenant Employed

One (1) Tenant receiving Provincial Training Allowance (PTA)

Rent/Mortgage Portion = \$463/mo. Incl. insurance/user fees

\$463 divided into 3 = \$154.33/mo.

\* It is important to mention that this formula also applies to <u>all utilities</u> for the unit, as well as <u>fuel costs</u> (oil/propane).

### **Other Programs CMHC**

CMHC also provides program dollars that anyone can apply to each year for renovation projects for homes, these initiatives are called the Residential Rehabilitation Assistance Program (RRAP) and the Home Adaptation for Seniors (HASI) – please check out their Web Page for a detailed description of these programs.

### RRAP

can be applied to as regular or disabled; this program provides renovation dollars for any non-section95 home on the reserve up to an amount of \$1,600 – a Band can apply for as many as they want, but are generally designated an amount based on their membership on reserve.

Accessing these dollars is a long drawn out process: step 1 make the application, step 2 call an inspector to come out and review the needs identified and add, or take away from the list, step 3 a tender must be sent out (contractors bid on the work) step 4 hopefully we can get the dollars in time to get the work completed before the deadline(s).

### HASI

meant to assist seniors – the amount of this grant is \$3,500; application and approval as the above described RRAP.

### In Closing

Our community is at an important crossroads, either we change the way we conduct ourselves, or we continue to dig ourselves deeper into a hole that we will never be able to get out of.


The fact of the matter is this: if we don't get our rental program in order there is no money going into the Operating Reserve Account (ORA), therefore there is no money for renovation or repairs of any kind – for any of the 64 section95 units. BBC, RRAP and HASI dollars can only be used for renovations to band homes, not under the Section95 agreements.

Currently, all rents/mortgages (including 30 Section10Units) are coming from the Band budget at a rate of around \$384,000/Yr. According to our history with the rental program, we haven't collected rent for at least the past 7 years. If you consider this in terms of dollars:  $7yrs \times 384,000/yr = $2,688,000.00$ . By our own inaction, we are all contributing to our own debt. More importantly we will not be eligible for any new housing in the near or distant future.

As for Public Works, based on our current portion of the budget allotment received from AANDC used for the Operations & Maintenance of our communities entire infrastructure (\$505,000.00/yr), we are expected to provide Maintenance Services for all of these items: Water Treatment Plant, Water Hauling, Sewer, Garbage, Roads, All Band Buildings, and Emergency Home Maintenance items for up to 300+ homes in our community. If we do not implement the insurance and user fees, the services that the PW&H can offer will always remain substandard in all of these areas. The money required to carry out these regular maintenance services for the Health & Safety of our community is just not there without it.

We are a proud 'Independent Band' doing the best we can with whatever we have. Unlike the very few other Bands out there who are fortunate to have access to resources that give them the ability to be self-sufficient, we rely on whatever is provided to us, by an outdated, one sided, never changing system.


### This is an update to the community from the Justice Department



**Memo To: Income Assistance Clients**

First of all, we wish to <u>CONGRATULATE</u> all the 2015 Grads, and for those graduating from Grade X11, we hope that you will continue with your Education and find a Career that you will enjoy. Those that have graduated from Universities and Trade Schools, we wish you success in securing full time employment soon. We cannot stress enough the huge difference between earning a decent wage rather than living on \$255.00 basic assistance and not being able to afford anything extra and the shortage of monies while on S/A.

Just a few reminders to Social Assistance Clients:

- 1. If you are an S/A client and are receiving your utility bills (Power, Energy) at your home address, please drop off your bills to Social Development Office as soon as you receive them to avoid any unnecessary late charges, disconnections, reconnection fees, finding all missing bills, etc. The Department of Indian Affairs do not pay for late fees, reconnections fees, disconnection fees and these fees will need to be recovered from your basic assistance, therefore, putting an overpayment on your file and getting a deduction on your cheques until these fees are paid in full.
- 2. Please advise of any changes that may occur while you are on Social Assistance. Some examples of changes are: Finding employment and working, living off the reserve, moved to a different house on reserve, change of mailing address, etc. Thanks to those people who phone immediately if they have found work or if they have moved off the reserve. To those Income Assistance Clients who continue to try to pick up a cheque without letting us know that they are working, sooner or later we find out and a huge overpayment will be placed on your file with a possibility of fraud charges.
- 3. Employment Assistance is given out only once per year for each Individual. It does not matter if you received your cheque from NCB or from Social Assistance.

**Indian Registry** 

#### **PRIVACY**

For your protection and to prevent identity theft, all IRA officers are required to adhere to the "Privacy Act". We are sworn to confidentiality of all information that we are privy to.

If you are phoning the office to obtain another member's information this information will not be released to you.

In the case of a minor, the parent or legal guardian may obtain the child's information providing the appropriate identification and proof is provided to the IRA. The membership office is not obligated to release personal information to any organization, third party or an individual who is not the parent or legal guardian.

#### **BIRTH REGISTRATION**

Registration is the sole responsibility of the birth parents or legal guardian of the child. AANDC does not automatically register your child at birth. The membership office's responsibility is to collect the forms, send to AANDC where the child is registered.

The documents required to register your child are:

- \*Child application for registration available from AANDC or band office
- \*Long form birth certificate EHealth

Both parents are required to complete the child registration application if both parents signed the live birth in the hospital. If only one parent signed the live birth you can still amend the live birth to add the other parent. (This process is with EHealth) Remember if the other parent is not stated on the birth document the child may not be entitled to registration or the child will be registered as 6(2) category and will not be able to pass on Indian Status.

The IRA can request the birth document from AANDC but not guaranteed we will receive it.

If the birth document is unattainable the parents will have to purchase at a cost of \$25.00. (eHealth)

Registration is not immediate it takes time to obtain the birth document. If you purchase this it will speed up the process. AANDC requires the original birth certificate but they will return it to you.

### **RECORDING EVENTS**

In order to keep the Indian Registry current it is imperative to record marriages, divorces and name changes, etc. To record these mentioned events legal documents are required.


# An application for an individual under 12 years of age must be accompanied by:

- Two pieces of ID- Parent/Guardian ID from Category 2 & child's ID from Category 1 or 2.
- \*\*\*if a legal guardian is applying on behalf of the child a copy of the legal guardianship order naming the guardian is required \*\*\*

An applicant between the ages of 12 and 16 may choose to meet either identification requirements.

### Note to Indian Registration Administrator (IRA):

The Department of Aboriginal Affairs and Northern Development Canada monitors the Certificate of Indian Status Cards being issued to ensure they meet the standards set out in the Indian Registration Administrator Training Manual - Chapter 6. To ensure that the cards are being processed according to the manual, please ensure you are adhering to the above rules to ensure you are able to continue issuing cards: If these identification requirements are not being met, the amount of cards sent to you will be reduced or terminated.

### Land purchase from BTC in the Cities of Saskatoon and North Battleford

The attached report provides an update as to the actions to date by both parties to the agreement and it presently in the hands of the Provincial Government's Land Department and Aboriginal Affairs and Northern Development under the Treaty Land Entitlement Process. The intent for the land is to have Beardy & Okemasis First Nation purchase the land from BTC and turn it to "Reserve Status". The plan for the lands includes Gas Bars, low-income housing and RV Park. The land will be "Head-Leased" back to BTC at fair-market value and the Beardy & Okemasis First Nation, through the Development Corporation, will be able to lease the lands back to BTC's Business arm and share in the profits of any businesses that are established. This partnership and its associated ventures will also include employment opportunities for our band members.

### **Native American Resource Partners - Quantum Investments**

NARP has entered into a Memorandum of Understanding with the Beardy & Okemasis First Nation to enter into a partnership on Oil and Gas Developments. The partnership has to be consummated with the voting and passage of the First Nations Oil and Gas Monies Management Act (FNOGMMA) by the Beardy & Okemasis membership. Firstly, the process of entertaining FNOGMMA has to be approved by Aboriginal Affairs and Northern Development (AANDC) and once it is approved then the (AANDC) will provide the Beardy & Okemasis First Nation with \$150,000 (One Hundred and Fifty Thousand Dollars) to proceed with Community Consultations so we can educate our membership as to what the FNOGMMA process is all about. NARP has also committed funds to the consultation process however, at this time it is not known what amount they will commit. Once the consultation process is completed then the membership will be required to vote on the legislation and once it is passed and the FNOGMMA Legislation receives Government approval then Quantum will provide the funds to Beardy & Okemasis First Nation, through its Development Corporation, to commence purchase of the lands. To this end NARP has provided the Beardy & Okemasis First Nation Land Management program with 35,000 acres of identified land in the South-West part of the Province through their geologists and Oil and Gas experts. The Land so identified has

been "Frozen" under the Treaty Land Entitlement Process by our Lands Program. This particular initiative is controlled by 2 factors, which include the approval of AANDC to proceed with the FNOGMMA process and the vote by the membership to approve the FNOGMMA Legislation. Once both have been achieved then the Development Corporation will proceed with the go ahead with Oil and Gas Developments with NARP and Quantum. The membership will be advised of all Community Consultation meetings, including those in the major Cities where our membership reside.

# Innergex Resources and Yotin Wind Power Project

The Beardy & Okemasis First Nation entered into a Memorandum of Agreement with Innergex Resources for the establishment of a Wind Power project on our Lands in the Dafoe area. This project has been an ongoing initiative with the help of the Saskatchewan Research Council and has included continued wind data collection through the construction of 5 Met Towers which are specifically erected to measure wind speed. The data collected to date rates the wind velocity to the ranking of "excellent" and the process has now evolved into a matter of garnering a "Power Purchase Agreement" with SaskPower. Our initial meeting with SaskPower officials in Regina was fruitful in that we were able to get a good indication of what our team would be required to take into consideration when pursuing the Power Purchase Agreement. With the help of the Sask. Research Council personnel and Mr. Peter Gardippi along with Innergex, we have been able to take the initiative to a stage whereby we will be having another meeting with SaskPower officials on May 14, 2015 to discuss a Power Purchase Agreement. It should be noted that the Beardy & Okemasis First Nation has been getting support from Personnel with the First Nations Power Authority (FNPA). This are entity that was established by the Minister of Energy Mr. Bill Boyd to coordinate energy developments by First Nations into one coordinating agency. In the most recent review of wind velocity, Innergex and the Sask Research Council have indicated that there is a plan to put up 50 Wind Towers in the Dafoe Lands and the estimated revenues from these is estimated to be about \$17 million dollars per year if we are allowed to build a 100 Megawatt Wind Farm. This would be attainable if we got a Power Purchase Agreement with SaskPower for 0.10/kWh. Innergex estimates that this would be about a \$250 to \$300 Million dollar project.

# **I&M Welding Joint Ventures**

The Beardy & Okemasis First Nation and I&M Welding Joint Ventures have signed a business joint venture. The Joint Venture is being created to pursue business and employment opportunities in the mining and oil and gas sectors in Western Canada for members of the Beardy & Okemasis First Nation. I&M Welding Joint Ventures is owned by Dwayne Hounsell and Mike Tumbach out of Saskatoon and Roy Petit will be the Beardy's & Okemasis representative at all future meetings with prospective Companies etc.

### **BHP Opportunities Agreement**

BHP Billiton is in the process of building a potash mine by our lands near Wynyard, Saskatchewan. Negotiations with BHP initiated July 2011 and on October 7, 2014 the Beardy's & Okemasis First Nation finalized an opportunities agreement with BHP Billiton Canada Inc. The next phase of our dealings with BHP is to ensure the opportunities agreement is implemented effectively and opportunities flow to our Nation. This agreement has the potential to benefit our community in the areas of education and training, community development, employment, capacity building and business opportunities.

### **Native One Financial**

The Beardy & Okemasis First Nation signed on with Native-One Financial and its subsidiary, Native-One Institutional Trading, to have a share with the first Native American owned Brokerage firm to have a seat in the New York Stock Exchange. Native-One Financial is a Native American and First Nations owned institutional investment company located in Leonardo New York City. Institutional investors are entities that pool large amounts of funds of behalf of others and invest those funds in a variety of financial instruments and asset classes. By being a part of Native-One Institutional Trading, Beardy's & Okemasis First Nation and Willow Cree Developments will have access to additional sources of business financing for economic development projects.

# **Willow Cree Developments**

Willow Cree Developments has been established as a legal entity. The purpose of this corporation is to establish an entity separate from the Chief and Council that will undertake business development at arm's length. This will also ensure that the business development process is non-political and that business decisions are made on the basis of viability, profitability and investment return to the First Nation. The corporation currently has Trustees who will appoint a Board of Directors made up of three Band members and two non-members in the next few months.

### Enbridge Pipelines

The Beardy & Okemasis First Nation is pursuing an agreement with Enbridge Pipelines for Employment and Business Opportunities with their Line 3 Replacement Project, as well as, the main Pipeline Project. We will provide updates as we progress on this potential partnership.

# 28/2 Permits to long term Leases

28/2 Permits are now being changed to Leases for the rental of lands, as the 28/2 permits expire we are in the process of changing to the long term lease agreements to reflect the designation process. We have also increased our rentals rates ranging from \$43.00 per acre to \$60.00 per acre for off reserve farmers. The process has a greater increase in paper work as we now implement an environmental component to the application and registration process.

### **Flooding**

The Lands department along with SAL Engineering coordinates the road repair project caused by flooding and flooding issues as well as the drainage ditch project. SAL manages the funding for these projects for 2015. We will be repairing three (3) sites that had damage due to flooding as well we have received approval for funding to start on the Drainage Ditch Project.

Urban Systems, a company that focuses on community development sees the potential of our site. We are in a prime location to do business for a long time to come.







Tansi, I just wanted to give the band membership a quick update in the sports and Rec program, as most are aware that we did not enter the Prince Albert Youth Soccer Association this year, I did put the a letter on our Chief and Council page and I do apologize for not sending a memo home, because not everyone has Facebook or access to a computer/phone.

The reason being for no soccer was the cost, last year we spent approximately \$40,000 on registration fees and transportation. Last year we were lucky that Northern Lights Community Development Corporation (CDC) had a 5<sup>th</sup> quarter, basically extra money that wasn't used by the other bands/towns, and we used these extra dollars (\$30,000) to help cover the costs of soccer/transportation.

Please need to understand that the Sports and Recreation program is a <u>non-government funded</u> <u>program and does not receive funds through the Financial Transfer Agreement (FTA). We are funded through Trust dollars from gaming (SIGA), CDC applications and/or grants.</u>

We are trying to organize a house league (soccer/softball) with our neighboring reserve One Arrow; we had a few discussions with Councillor Janine Baldhead so please be on the lookout for sign-up sheets. We want to involve our kids from 6-18 yr. olds in house league soccer for the months of July and August, this will keep them busy and yet prepare them for the Summer Games (Ochapowace, Aug 9-15, 2015). One Arrow wants to host a Fun Softball tournament, June 27 starting at 10am for the ages of 12-18, if interested in playing please contact me or also volunteering.

For the soccer program, we decided to have a kick-off BBQ at Rosthern Park – July 4<sup>th</sup>, this will enable the kids to have a meet and greet, have some fun and a lil BBQ.



It's been a very busy few months but I am pleased to submit this report to our membership to update you on my activities thus far. I also would like to thank everyone for their continued support as we strive to achieve our shared goals for our community.

I want to acknowledge the families in our community who lost a loved one during the last few months. Indeed, this has been a trying time for all of us and it gave me great comfort seeing our community members unified in their support of and solidarity with one another.

#### **Personnel**

I would like to formally welcome Jaye Cameron as our new permanent Human Resources Officer, Mrs. Cameron is currently working on many HR administrative functions. specifically on updating all of the Job Descriptions and adding them to the DRAFT, Revised Personnel Management Act & Regulations (PMAR). #### Community Development

<u>Community Development Plan</u>: Our Council has accepted the final Community Development Plan submitted by Urban Systems for our First Nation. Big thanks go out to our partners BHP and Urban Systems for working with community members to identify YOUR priorities and guide our collective progress moving forward.

BHP Opportunities Agreement: While the Opportunities Agreement with BHP continues to pose minor challenges, we are pleased to say that we will soon see the fruits of our labour.

Work with the Senior Advisory Team (Councillors Leighanne Gardipy-Bill, C. Roy Petit, and Jeremy Seeseequasis) will yield considerable benefit for our community. Specifically at this time, we have submitted proposals to best utilize the \$200,000 allocated for Community Development. All submitted projects are in accordance with the Community Development Plan referenced above.

Your Community Development projects include:

- 1. Governance Development funding to continue our Governance objectives.
- 2. Youth Center Supplies funding to purchase games, furniture, and anything/everything required to open up a Youth Centre.
- 3. Electronic Community Billboard funding to purchase a 7'x 4' digital billboard to advertise community events/important announcements.
- 4. Camp Tawow Renovations funding to renovate Camp Tawow.
- 5. Emergency Response Supplies funding to purchase Emergency Management supplies to aid in the event of a natural disaster.

Other opportunities exist in the areas of Economic Development and Employment and Training. Those are detailed by the Team Lead's specifically responsible for those areas.



Sisip Sakahikan Community Development Trust (SSCDT): Wow! Support for the In-House and Radio bingos has been phenomenal! We're very excited to be providing these fundraising activities in our community.

The SSCDT was established as an unincorporated, non-profit organization through Band Council Resolution #2014-2015-045 on January 29, 2015. All activities of the organization are overseen by the Indigenous Gaming Regulators, Inc.

The purpose of the organization is to enhance and support community initiatives and organizations by generating revenue through on-reserve gaming (bingos etc). As an unincorporated, non-profit organization operating within the Beardy's & Okemasis First Nation, the SSCDT is responsible to equitably distribute all the funds generated to community organizations and individuals.

Funds will be distributed according to 4 priority areas (PERC): 1) poverty reduction; 2) education advancement; 3) recreation promotion; 4) community and general benefit to our members.

Here is a brief financial breakdown of the SSCDT:

1. Funds Raised to date: \$5,244,25

2. Total Prize Money Paid Out: \$8,843.00

3. Assistance Provided: \$1,475.00

4. Expenses: \$1,167.46

It should be noted that assistance is *not available* for the following:

- 1. Rent
- 2. Furniture
- 3. Damage Deposits
- 4. Utilities

All finances are regulated through the Indigenous Gaming Regulators. I'm very proud that all funds raised by our community stay in our community. We are doing each other a great service by assisting one another in this way. A full financial report will be provided at the Annual General Meeting for the SSCDT at a to-be-determined date. If you have any questions or concerns, please feel free to contact any member of the Board of Directors at the Band Office.

Mental Health Awareness Week: I was so honoured to have participated in Mental Health Awareness Week activities hosted by Willow Cree Health. I wish to commend all the staff and

volunteers who worked so hard to make that initiative a success. Mental Health affects us all in some way, shape, or form – either directly, or indirectly. Congratulations on a job well done!

Truth & Reconciliation Final-National Event: What a beautiful experience to arrive in Ottawa (not at the Band's expense) at the Delta Convention Centre and smell the fragrant scents of sweetgrass, sage, cedar, and tobacco — all our medicines blessing all the survivors and participants as they walked in. Hand drummers frequently sang and complete strangers consoled each other as survivors shared their stories, or heard other survivors' stories. It was again a beautiful display of unity and a testament to the resilience of First Nations people at the hands of a government's genocidal agenda. It was inspiring to see so many people – and the public's attention – to the goal of reconciliation in Canada. It will undoubtedly be a long journey, but for the child taken, and the parent left behind; we owe it to their memory and the future prosperity of those not yet born.



The past 16 months have been incredibly rewarding and eye-opening. I want to thank everyone for their continued patience, support, and understanding. Our Council continues to make the decisions necessary that we feel will benefit our community over the long term.
